The Board Meeting of the Enclave Fair Lakes Homeowners Association was called to order at 6:03

- A. Welcome Stuart Prince welcomed everyone and introduced the Board of Directors explaining that the Board currently is a Declarant Board.
- B. Roll Call & Verification of Quorum A majority of the Members were in attendance as required by the By-Laws

 - b. Debbie & Keith landscaping issues signs that say residents only for the amenities, will the property be mulched
 - c. Jason Siegel and Rebecca Park focusing on exterior home services like gutter cleaning etc.
 - d. Zhenqian Huang question about trash pickup does not like once a week pickup
 - e. Jad Reyes lighting installation what kind of light also has a question about a storm drain
- I. Management/Board Response to Open Forum
 - a. Cannot put speed bumps on Fair Lakes Court since it is a Fairfax County Road.
 - b. We can consider pickleball and will look at this.
 - c. Right now if the dead plant is on a lot Integrity Homes warrantees it. Peterson will address landscaping during the budget process. Homeowners should take a photo of the dead plant and sent a photo along with the location to Meera and she will figure out which entity is responsible.
 - d. Economies of scale gutter cleaning etc. Meera suggested that homeowners connect with other homeowners right now on this and Stuart Prince said that the Board will also give some thought to this.
 - e. Trash pickup Stuart Prince reported that Fairfax County dictated the trash pickup reduction to once a week and American Disposal is having a labor shortage. We have a three year contract. Meera reminded everyone of the trash and recycling rules. She will begin fining consistent violators.
 - f. Todd addressed lighting residents should see the lights coming on in the next 30 days. Todd added that the rocks in front of the storm drain are part of the erosion control.
- J. Next meeting the next meeting will be scheduled before the end of the year when the budget will be approved.
- K. Adjournment there being no further business to discuss the meeting was adjourned at 6:35.
